Supervisor Credentials	An approved supervisor is a practitioner with three years of Full Time or the equivalent Part Time post-licensure clinical Mental Health Counseling experience who is also either: a. MA Licensed Mental Health Counselor, LMHC b. MA licensed independent clinical social worker, LICSW c. MA licensed marriage and family therapist; LMFT d. MA licensed psychologist with Health Services Provider Certification; e. MA licensed physician with a sub-specialization in psychiatry; f. MA licensed nurse practitioner with a sub-specialization in psychiatry; or, g. where practice and supervision occur outside of the Commonwealth of Massachusetts, an individual who is an independently licensed mental health practitioner	

Notes on Supervision: (1) in Massachusetts, either pre or post master's degree you must accumulate 75 hours of supervision with an LMHC or equivalent out of state counselor credential
