

What is the TEACH Grant?

The Teacher Education Assistance for College and Higher Education Grant (or TEACH Grant), was instituted on July 1, 2008 by the Department of Education (DOE), in conjunction with the College Cost Reduction and Access Act. The TEACH Grant is designed to encourage highly qualified teachers to serve low income schools in high-need subject areas.

Please note that there are several requirements which are necessary to qualify for the grant, as well as a number of requirements which must be fulfilled in order to keep the grant. Students who do not meet the requirements to keep the grant will have those funds converted to an unsubsidized loan with added interest. Once a loan, it cannot be converted back to a grant.

How much money is available?

Undergraduate students may receive up to \$4,000* per year for full-time enrollment for a total of \$16,000 over the course of an undergraduate program. Graduate students may receive up to \$4,000* per year for full-time enrollment for a total of \$8,000 over the course of a graduate program. TEACH Grant amounts must be pro-rated for students who are not enrolled full-time.

Three-quarter time = \$3,000* per year and divided by the number of semesters enrolled.

Half-time = \$2,000* per year and divided by the number of semesters enrolled.

Less than half-time = \$1,000* per year and divided by the number of semesters enrolled.

*Actual amounts may vary based on congressional allocation so visit our website for up-to-date details.

Eligibility Requirements to Receive the TEACH Grant:

- Must file the FAFSA
- Must be a U.S. citizen or eligible non-citizen.
- Must be in good standing with the Title IV aid programs as reported by the National Student Loan Database System (NSLDS).
- Candidate must be enrolled in a TEACH-Grant-eligible academic program.
- Candidate must meet one of the following qualifications:

Must have and maintain at least a cumulative 3.25 GPA on a scale of 4.0 prior to enrolling at Lesley University program.

-OR-

Score above 75th percentile on a national admissions test (i.e. SAT/ACT/GRE).

-OR-

Be a current teacher or former teacher or retiree (in any field), enrolled in a TEACH-Grant-eligible master's degree program. (Former teachers must be pursuing high-quality alternative certification in a master's degree program.)

- Candidate must complete TEACH Grant Intent Form.
- Candidate must complete TEACH Grant Entrance Counseling and subsequent counseling every year.
- Candidate must sign the Agreement to Serve (ATS) each academic year.

Teacher Education Assistance for College and Higher Education (TEACH) Grant

The Financial Aid Office needs to confirm your intent to apply for the TEACH Grant for the 2021-22 academic year. Submit this form and submit it to our office to be considered for the TEACH Grant.

The TEACH Grant is a program designed to assist students entering or continuing a teaching career in a high-need subject area in a school that serves low-income students. PLEASE NOTE: If a student receives the TEACH Grant and does not meet all of the requirements deemed necessary by the Department of Education, the TEACH Grant is converted into a DIRECT UNSUBSIDIZED LOAN with back-added interest from the date the TEACH Grant was first credited to your student account. Once the TEACH Grant is converted into a loan, it cannot be converted back to a grant. Due to these serious financial consequences, it is important that students only apply for the TEACH Grant if certain that all the conditions and obligations will be met.

A. TEACH Grant application process:

- 1. You must complete the 2021-2022 FAFSA (Free Application for Federal Student Aid) at <https://studentaid.ed.gov/sa/fafsa> and complete the FAFSA every academic year.**
- 2. You must submit the 2021-2022 TEACH Grant Intent Form.**
By completing and submitting this form you certify that all information submitted on the form is true and agree to contact us if your status or circumstances change.
- 3. You must be enrolled in a TEACH Grant eligible academic program.**

- 4. You must complete TEACH Grant Entrance Counseling and subsequent TEACH Grant counseling every academic year.**

- 5. You must complete the Agreement to Serve (ATS) every academic year.**
The Agreement to Serve (ATS) is developed by the Department of Education and explains all of the requirements to receive the TEACH Grant and to keep the TEACH Grant from being converted to a Direct Unsubsidized Loan. Requirements to Keep the TEACH Grant:

VERY IMPORTANT: TEACH Grant recipients must fulfill all requirements set by the Department of Education (DOE) or the TEACH Grant will be

Converted into an interest-bearing Direct Unsubsidized Loan that will include interest charged from the date the TEACH Grant originally credited to your student account. Once the grant is converted to a loan, it can never be changed back into a grant. If at any point you decide that you do not want to fulfill the Agreement to Serve (ATS), you may contact the DOE and request the grant be converted to a loan.

•TEACH Grant recipients must be a full-time teacher for at least four years within eight calendar years of completing the TEACH-eligible academic program.

•TEACH Grant recipients must be deemed highly-qualified by the state in which he/she teaches per the No Child Left Behind Act.

•TEACH Grant recipients must teach in a Designated Low-Income school. Designated Low-Income School: a public or private elementary or secondary school that (1) Is in the school district of a local educational agency that is eligible for assistance under Title I of the Elementary and Secondary Education Act; and (2) Has been determined by the DOE to be a school in which more than 30 percent of the school's total enrollment is made up of children who qualify for services provided under Title I of the Elementary and Secondary Education Act. Schools are listed in the Department of Education's "Annual Directory of Designated Low-Income Schools for Teacher Cancellation Benefits" on the Department of Education's web page.

•TEACH Grant recipients must teach in a High-Need Subject Area in the majority of classes taught. High-Need Subject Areas currently include:

- 1. Mathematics
- 2. Science
- 3. Reading Specialist
- 4. Special Education
- 5. Foreign Language
- 6. Bilingual Education or English Language Acquisition (TESOL)
- 7. Other teacher shortage areas identified at the time the student begins the 4 years of service. Visit the DOE's "Annual Teacher Shortage Area Nationwide Listing" on the Department of Education's website.

NOTE: Most elementary teachers, unless teaching Special Education, English as a Second Language or serving as a Reading Specialist will likely not meet the full-time teaching requirement in the critical need field.

•TEACH Grant recipients must confirm within 120 days of graduating (or ceasing to be enrolled) that he or she is fulfilling or plans to fulfill the agreement to serve. Otherwise, the grant will be converted to a loan.

•TEACH Grant recipients must have their school of employment's chief administrative officer annually submit documentation to the DOE confirming the teaching service. This documentation must show that the TEACH Grant recipient is a full-time, highly-qualified teacher at a designated low-income school, teaching a high-need subject area. At the end of four years, the TEACH Grant recipient and the school's chief administrative officer must provide documentation to the DOE that the obligation was met.

TEACH Grant recipients must comply with any other requirements that the DOE determines to be necessary.
