## I. State Professional Mental Health Counseling Licensure

### Massachusetts Licensed Mental Health Counselor

Our 60-credit Masters of Clinical Mental Health Counseling programs, including specializations in Holistic Studies, School and Community Counseling, and Trauma Studies, meet the current educational requirements for Licensed Mental Health Counselor (LMHC) licensure in Massachusetts.

- The 60-credit Masters of Clinical Mental Health Counseling: School and Community Counseling specialization also **meets** the licensure requirements for Massachusetts Department of Elementary and Secondary Education (DESE) Initial Licensure (see II(a) below).
- Please note, the 48-credit School Counseling program **meets** the licensure requirements for DESE initial licensure (see below IIb), but **does not meet** the licensure requirements for Licensed Mental Health Counselor (LMHC) licensure.

### Out-of-State Professional Mental Health Counseling Licenses

Professional mental health counseling licensure requirements vary from state to state, are a matter of individual state legislation, and are outside of the control of educational institutions. State licensing boards make determinations as to whether an applicant's program of study meets the educational requirements for a license at the time of licensure application.

### State-by-State Listing: Professional Mental Health Counseling Licensure

- A. Lesley's University's 60-credit Clinical Mental Health Counseling programs' curricula **meet** the current educational requirements to apply for licensure in clinical mental health counseling in the following state(s): Massachusetts.
- B. Lesley University **has not made a determination** whether our Clinical Mental Health Counseling programs' curricula meet the current educational requirements to apply for licensure in the following states: Alabama, Alaska, Colorado, Delaware, Georgia, Hawaii, Idaho, Iowa, Kansas, Louisiana, Maine, Missouri, Montana, Nebraska, Nevada, New Jersey, New Mexico, New York, North Dakota, Oregon, Pennsylvania, Rhode Island, South Carolina, South Dakota, Washington, Wisconsin, and Wyoming, and in Puerto Rico.
- C. Lesley's University's 60-credit Clinical Mental Health Counseling programs' curricula **do not meet** the current educational requirements to apply for licensure in clinical mental health counseling in the following states, but graduates may be eligible to apply with supplemental course work or additional field training experiences: Arizona, Arkansas, California, Connecticut, Illinois, Indiana, Maryland, Michigan, Minnesota, Mississippi, New Hampshire, North Carolina, Ohio, Oklahoma, Tennessee, Texas, Utah, Vermont, Virginia, the District of Columbia, and West Virginia.
- D. Lesley's University's 60-credit Clinical Mental Health Counseling programs' curricula **do not meet** the current educational requirements to apply for licensure in clinical mental health counseling in the following states and graduates of our Clinical Mental Health Counseling programs are **ineligible for professional mental health counseling licensure** in the following states: Florida, North Carolina, and Kentucky.

Individuals who intend to pursue professional mental health counseling licensure in one of the states listed in B or C above are strongly encouraged to request guidance from state licensing boards as to whether supplemental coursework or other actions would be necessary to make them eligible to apply for professional mental health counseling licensure in that state. **II. Massachusetts Department of Elementary and Secondary Education (DESE) Initial Licensure:**

**a. School Adjustment Counselor (all grade levels: preK-12) Initial License**

Lesley University's School Adjustment Counseling in our 60-credit Masters of Clinical Mental Health Counseling: School and Community Counseling program **meets** the current educational requirements of this type of Massachusetts initial license upon degree completion.

**b. School Counselor (grade levels: preK-8 or 5-12) Initial License**

Lesley University's School Counseling in either our 48-credit Masters of Counseling Psychology: School Counseling program or our 60-credit Masters of Clinical Mental Health Counseling: School and Community Counseling program **meets** the current educational requirements of this type of Massachusetts initial license upon degree completion. Note: The 48-credit School Counseling program does not meet the licensure requirements for the Licensed Mental Health Counselor license in Massachusetts.

**State-by-State Listing: School Adjustment Counselor, All Levels and School Counselor (Pre-8 or 5-12)**

**A.** Lesley's School and Community Counseling and School Counseling programs' curricula **meet** the current educational requirements to apply for the School Adjustment Counselor and School Counselor initial licenses (respectively) in the following state(s): Massachusetts.

**B.** Lesley University has **not made a determination** whether our School and Community Counseling and School Counseling programs' curricula meet the current educational requirements to apply for School Adjustment Counselor or School Counselor licenses, or similarly-named licenses, in the following states: Alabama, Alaska, Arizona, Arkansas, California, Colorado, Connecticut, Delaware, Florida, Georgia, Hawaii, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, Pennsylvania, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Vermont, Virginia, Washington, West Virginia, Wisconsin, Wyoming, the District of Columbia and Puerto Rico.

Individuals who intend to pursue School Adjustment Counselor or School Counseling licensure in one of the states listed in B above are strongly encouraged to request guidance from state licensing boards as to whether supplemental coursework or other actions would be necessary to make them eligible to apply for School Adjustment Counseling or School Counseling licensure in that state.
