

## **Informed Consent**

## **Online Survey Research Consent Example**

Survey research still requires informed consent and that can consist of giving the key information needed for consent to respondents at the beginning of the survey and then letting them "agree" by moving forward with the survey as the example below indicates. Note that the example text below indicates that no identifying information will be collected and uses XXX for details that researchers need to fill in about their specific projects.

You are invited to participate in a research project titled "xxx." The intent of this research study is to identify attitudes, strengths, and limitations in the field of xxx to identify implications for training, research, and practice.
